# GOVERNMENT OF CANADA – INDIGENOUS SERVICES CANADA URBAN PROGRAMMING FOR INDIGENOUS PEOPLES (UPIP)

**DESCRIPTION:** UPIP is designed to assist First Nations (status and non-status), Inuit and Métis living in or transitioning to urban centres. An urban centre is considered to be an urban area having a population of at least 1,000 people and a population density of no fewer than 400 people per square kilometre. Funding is also available for organizations that serve rural and northern areas that act as hubs for those living on reserves or in smaller northern settlements.

# **Funding Streams**

UPIP has four streams of funding:

- Organizational Capacity: This stream offers core funding for up to five years to Indigenous
  organizations that deliver programs or services to urban Indigenous peoples. Core funding
  covers the day-to-day operating costs of an organization, like staffing of key positions,
  utilities, rent, etc.
- <u>Programs and Services</u>: This stream provides project funding for up to five years to
  organizations that deliver programs and services to Indigenous peoples in urban areas.
   Projects that focus on these six key areas will be considered for funding: women, vulnerable
  populations, youth, transition services, outreach programs, community wellness.
- <u>Coalitions:</u> This stream supports local coalitions that bring together all levels of government
  and other stakeholders that identify key local priorities and needs and ensure efficient and
  coordinated delivery of urban Indigenous programs. The coalitions will promote local
  collaboration, identify local needs, and develop local plans on how best to address the
  priorities. (The funding for this stream will be delivered through targeted calls for proposals.)
- <u>Research and Innovation:</u> This stream provides funding to academics, researchers and
  organizations in order to: better understand the urban Indigenous reality, gather
  information on best practices, methodologies and programming approaches, and pilot
  innovative programs and services to address systemic challenges in new ways

**ELIGIBILITY:** Each stream of UPIP funding has its own eligibility requirements. Common requirements for all streams include:

- recipients must be located in an urban centre
- all initiatives and projects must advance the objectives of Urban Programming for Indigenous Peoples
- all non-Indigenous organizations, including municipal governments, health and education authorities
  and institutions, require demonstrated support from Indigenous organizations or Indigenous community
  groups to be eligible for funding.

# **GOVERNMENT OF CANADA- NATURAL RESOURCES Clean Energy for Rural and Remote Communities (CERRC) Program**

**DESCRIPTION:** The CERRC program will support a suite of diverse projects across Canada, to reduce the reliance of rural and remote communities on diesel fuel for heat and power.

Project proposals will be evaluated against a range of criteria, and need to demonstrate local community support and outline the community benefits of the project, particularly for Indigenous communities. Projects must fit into one of the following streams:

### **Funding Streams:**

- •BioHeat \$55 million for feasibility studies and/or installation of proven biomass combustion heating systems, district heating and combined heat and power systems that displace diesel or certain other fossil fuels used for heating. Electricity may be produced, but the primary output of the project must be heat.
- Demonstration \$60 million to demonstrate innovative renewable energy, energy efficiency, energy storage or smart-grid technologies to displace diesel fuel for power and/or heat. Deployment \$90 million for deployment of commercially available renewable energy technologies for electricity. Heat may also be produced, but the primary output of the project must be electricity. Call for Preliminary Proposals
- Capacity Building \$10 million for the development of energy literacy and local technical expertise through skills training and network participation in rural and remote communities. nrcan.gc.ca/energy/science/programs-funding

### **Eligible Recipients**

- For-profit and not-for-profit legal entities validly incorporated or registered in Canada
- Provincial, territorial, regional and municipal governments and their departments and agencies where applicable
- Indigenous communities or governments; tribal councils or entities that fulfill a similar function (e.g. general council or tribal organizations) and Indigenous for-profit and not-for-profit organizations. Community Participation and Ownership
- Projects that incorporate aspects of community participation beyond consultation, e.g. community ownership or management, will be given priority. The level of community involvement will be reflected in how proposals are scored. The level of Indigenous involvement will be evaluated more favourably.

Complete and submit a project proposal including any other required documents by **April 12** to be eligible for a\*preference for projects that include opportunities for community and/or Indigenous participation and ownership

# GOVERNMENT OF CANADA- NATURAL RESOURCES CANADA INDIGENOUS FORESTRY INITIATIVE

**DESCRIPTION:** The Indigenous Forestry Initiative is a program that provides funding to support the economic development of Indigenous peoples in Canada. The activities we fund promote greater participation by Indigenous communities in all natural resource sectors, especially the forest sector.

### PROJECTS CONSIDERED FOR FUNDING

Projects must be aimed at achieving economic development through one of the following activity areas:

- Clean technology and participation in the forest bio economy (e.g. a project that promotes using biomass for heat and power to reduce reliance on diesel fuel)
- o Environmental stewardship (e.g. a project that focuses, on climate change mitigation and adaptation, land reclamation, or environmental/ecological services)
- Use and management of forest resources (e.g. a project that gives people in the community training in forest management)

Eligible projects must have at least one partner (e.g. federal or provincial government, industry, or research organization) that has agreed to contribute financially or with in-kind goods or services.

#### **ELIGIBILITY**

Indigenous communities and governments such as:

- band and tribal councils
- governments of self-governing First Nations
- local governments of Inuit communities
- Métis organizations
- economic development corporations
- for-profit and not-for-profit corporations, partnerships, joint ventures, associations, co-operatives
  and institutions that are Indigenous or majority-owned and controlled by Indigenous people or fully
  endorsed by an Indigenous partner organization or community
- provincial, territorial, municipal and regional governments working with an Indigenous partner organization
- · academic institutions and research associations working with an Indigenous partner organization

# GOVERNMENT OF CANADA – INDIGENOUS SERVICES CANADA ABORIGINAL BUSINESS AND ENTREPRENEURSHIP DEVELOPMENT

### NOTICE

**DESCRIPTION:** ABED works with Indigenous entrepreneurs and its partners to provide a range of services and supports that promotes the growth of a strong Indigenous business sector in Canada. Support will vary depending upon the needs of the client, the availability and sources of funding, the eligibility of costs, the economic benefits, and the project viability. Through the Program Delivery Partners (PDP) initiative, INAC partners with Aboriginal Financial Institutions (AFIs) to deliver funding for business development. AFIs are located in all regions of the country and are well-positioned to meet the needs and aspirations of Indigenous entrepreneurs and communities at the local level. AFIs have responsibility for the management, distribution and administration of an equity fund and have the authority to approve funding for activities up to a maximum of \$99,999 for Indigenous individuals and incorporated businesses and up to \$250,000 for community owned businesses.

### **Funding Supports Provided by ABED**

Many Aboriginal entrepreneurs and communities can qualify for business development support. Depending on the nature of your project, you may be able to obtain funding to assist with a wide range of activities, including:

- Business planning
- Establishment (capital) costs
- Business acquisitions
- Business expansions
- Marketing initiatives that are local, domestic, or export oriented
- New product or process development
- Adding technology to improve operations and competitiveness
- Operating costs in association with capital costs
- Financial services, business support, business-related training, and mentoring services

### **ELIGIBILITY**

Clients must be individuals of Canadian Indigenous heritage — Status or Non-status Indian (on or off-reserve), Métis or Inuit — or a majority-owned Indigenous business, or an Indigenous community and/or development corporation. To be eligible for support, clients should also be involved full-time with the proposed business in a management capacity and must be able to provide some level of cash equity to support the project.

# CANADA MORTGAGE AND HOUSING CORPORATION DIRECT LENDING PROGRAM

**DESCRIPTION:** Canada Mortgage and Housing Corporation's Direct Lending Program provides financing and renewals for eligible social housing projects and offers the lowest average financing rate available. All loans that are financed or renewed at the same time and for the same term receive an identical rate regardless of the size of the loan or the location of the project. CMHC commenced Direct Lending to finance new commitments and renewals for social housing projects in order to reduce subsidy expenditures and make the best possible use of financial resources.

### **ELIGIBILITY**

Financing is available to First Nation councils as well as sponsors of on-reserve affordable housing projects. Councils and sponsors can use the financing to meet new housing project commitments or renew existing project loans.

# CANADA MORTGAGE AND HOUSING CORPORATION HOUSING INTERNSHIP INITIATIVE FOR FIRST NATIONS AND INUIT YOUTH

**DESCRIPTION:** This program provides financial assistance to help First Nations and Inuit businesses and organizations create housing-related internships for youth. These internships can provide much-needed work experience and on-the-job training to youth.

Internship opportunities can include positions in: administration, maintenance, construction, renovation and client counselling

### Who can sponsor a trainee?

Financial assistance to employ youth is available to a wide range of First Nation and Inuit organizations. Sponsors of youth trainees can include businesses, councils and self-government entities. As a program sponsor, you must:

- have the time and staff resources available to provide on-the-job training
- have an office in a First Nation or Inuit community (or within commuting distance for the trainee)
- cover the trainee's travel and accommodation costs (if you're located outside the community)
- cover all administrative costs related to the trainee's position (such as supervisor's time or the provision of safety equipment)
- hire the trainee for a minimum of 8 weeks, up to a maximum of 2 years

### **ELIGIBILITY**

Indigenous Youth must be between the ages of 15-30, and be out of school and not otherwise employed throughout the internship, not receiving Employment Insurance benefits or agree to discontinue benefits when the internship begins. Youth do not have to reside on reserve.

# NEW HORIZONS FOR SENIORS PROGRAM- COMMUNITY-BASED PROJECTS

**DESCRIPTION:** Organizations that want to help seniors make a difference in the lives of others, and in their communities, are eligible to receive federal grants and contributions funding. Projects must be led or inspired by seniors and address one or more of the following five program objectives:

- promoting volunteerism among seniors and other generations;
- engaging seniors in the community through the mentoring of others;
- expanding awareness of elder abuse, including financial abuse;
- supporting the social participation and inclusion of seniors; and
- providing capital assistance for new and existing community projects and/or programs for seniors.

### **ELIGIBILITY**

- not-for-profit organizations (e.g., churches or church associations, charities, activity clubs, volunteer organizations, professional associations, museums, or in some cases sports associations);
- coalitions, networks;
- municipal governments;
- research organizations and institutes;
- Educational institutions (e.g., universities, colleges, CÉGEPs), public health institutions and social service institutions are eligible with the agreement of the provincial or territorial government. For this call, these institutions in Alberta, Manitoba, New Brunswick, Nunavut, Quebec and Saskatchewan are eligible;
- band/tribal councils and other Aboriginal organizations;
- for-profit enterprises (non-commercial, does not generate profit)
- school boards/school districts.

COMMUNITY-BASED PROJECTS ARE ELIGIBLE TO RECEIVE UP TO \$25,000 PER YEAR, PER ORGANIZATION, IN GRANT FUNDING OR A SMALL GRANT OF A MAXIMUM OF \$5,000.

ORGANIZATIONS CAN APPLY FOR FUNDING FOR COMMUNITY-BASED AND PAN-CANADIAN PROJECTS IN THE SAME YEAR WHEN CALLS FOR PROPOSALS ARE OPEN.

### **ELIGIBILITY**

### Organizations must be:

- Non-profit societies that have been registered as such for at least one year before applying for a hosting grant.
- Amateur sport or recreational events must be:
- Endorsed or sanctioned by the appropriate provincial, western Canadian, national or international body.
- Determinative of the champion for the respective level of competition.

- Open and not restricted to members of certain groups or clubs.
- Multicultural events must be:

Banquets, conferences, symposia and similar events are not eligible for hosting grants. The City does not award hosting grants to educational institutions or their affiliated foundations.

- Use the grant to further your mandate
- Should not substantially duplicate the activities of other applicants or other governmentsupported organizations

**FUNDING:** Eligible organizations may receive up to 25% of their eligible operating expenses of the previous fiscal year. The maximum grant award will not exceed \$20,000.

In addition, your organization or group must provide broadcast communications north of the Hamelin Line, which is drawn at the 55th parallel and defines the Canadian North for purposes of policy.

**2.** Aboriginal Business Investment Fund (ABIF) – ABIF program is a Government of Alberta approach to improving social and economic outcomes for Indigenous communities by building partnerships and investing in economic opportunities.

The ABIF provides funding to capitalize community-owned business development opportunities. The program offers direct investment into eligible Indigenous community-owned businesses. ABIF is intended for capital projects that are close to starting operations or breaking ground for building projects within the funding year. The projects must demonstrate long-term impacts as follows:

- increase the number of Indigenous community-owned businesses;
- increase the number of employment opportunities for Indigenous people;
- create or increase local revenue streams for Indigenous communities; and
- strengthen the economies of Indigenous communities.

An Indigenous community can only submit one ABIF application and business plan for consideration in any given funding year. Funding allocation is based on project evaluation against the scoring criteria and awarded on a competitive ranking.

The Department of Justice Canada provides funding for initiatives that support families of missing and murdered Indigenous women and girls: Family Information Liaison Units and funding for community-based organizations that provide culturally-grounded grief and trauma supports for families.

These initiatives are not part of the National Inquiry into Missing and Murdered Indigenous Women and

Girls. The National Inquiry is independent of all levels of government. These initiatives are a response to what we heard during the pre-Inquiry engagement from survivors, families, and loved ones affected by this long-standing national tragedy.

Supporting families of missing and murdered Indigenous women and girls on their healing journey is a priority for the Department of Justice Canada.

This is why we support community-organizations that deliver services for families of missing or murdered Indigenous women and girls. Funding for these activities will help fill gaps where needs are high, building on the work of Indigenous organizations and specialized victim services programs.

The purpose of this investment is to support culturally-responsive, trauma-informed community-based services for families of missing and murdered Indigenous women and girls. Culturally-responsive services for families are those that are grounded in or informed by the various cultures of the families in need of assistance. A trauma-informed approach is grounded in client safety and empowerment. Trauma informed victim service providers are guided by principles of creating a safe space, building trust, supporting client choice, respecting client control, and building on strengths. These principles are integrated into policies, procedures, practices and settings.

Projects funded will address gaps where there are limited supports and services for families. Funding will also be available to increase capacity where services are already being provided by Indigenous organizations.

Funding will be linked to the following Victims Fund objectives:

- 1. Promote access to justice and participation by victims of crime in the justice system;
- 2. Promote the development of law, policies and programs for victims of crime;
- 3. Promote the implementation of principles, guidelines and laws designed to address the needs of victims of crime and articulate the victim's role in the criminal justice system;
- 4. Increase knowledge and awareness of the impact of victimization, the needs of victims of crime, available services, assistance and programs, and relevant legislation;
- 5. Encourage governmental and non-governmental organizations to identify victim needs and gaps in services, and develop and deliver programs, services and assistance to victims of crime; and/or,


